NOTIFICATION

Whereas the draft of the following rules further to amend the Karnataka Civil Services (Classification, Control and Appeal) Rules, 1957, was published as required by clause (a), sub-section (2) of section 3 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) in Notification No. DPAR 27 SDE 2018, Dated: 11.02.2019, in Part IV A (P.R.No.105) of the Karnataka Special Gazette dated 11.02.2019 inviting objections and suggestions from all persons likely to be affected thereby within fifteen days from the date of its publication in the Official Gazette.

Whereas, the said Special Gazette was made available to the public on 11.02.2019.

And Whereas, no objections, and suggestions have been received in this behalf by the State Government.

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) the Government of Karnataka hereby makes the following rules, namely:-

RULES

1. Title and Commencement:- (1) These rules may be called the Karnataka Civil Services (Classification, Control and Appeal) (Amendment) Rules, 2018.

(2) They shall be deemed to have come into force with effect from 1st July 2017.

2. Amendment of Rule 5: In the Karnataka Civil Services (Classification, Control and Appeal) Rules, 1957, (hereinafter referred to as the said Rules) in rule 5, for sub-rule (3), and entries relating thereto the following shall be substituted, namely:-

(3) In the State Civil Services.-

a) Group "A" Shall consist of posts carrying the scale of pay off Rupees 52650-1250-53900-1450-62600-1650-72500-1900-83900-2200-97100 and above;

b) Group “B” shall consist of posts carrying the scale of pay of Rupees 40900-1100-46400-1250-53900-1450-62600-1650-72500-1900-78200 and above, but below the scale of pay of Rupees 52650-1250-53900-1450-62600-1650-72500-1900-83900-2200-97100;

c) Group “C” shall consist of posts carrying the scale of pay of Rupees 21400-500-22400-550-24600-600-27000-650-29600-750-32600-850-36000-950-39800-1100-42000 and above, but below the scale of pay of Rupees 40900-1100-46400-1250-53900-1450-62600-1650-72500-1900-78200 but other than the posts specified in Schedule-IV; and

d) Group “D” shall consist of posts specified in Schedule-IV and the posts carrying the scale of pay of Rupees 17000-400-18600-450-20400-500-22400-550-24600-600-27000-650-28950 and above, but below the scale of pay of Rupees 21400-500-22400-550-24600-600-27000-650-29600-750-32600- 850-36000-950-39800-1100-42000

Explanation:- For the purposes of this sub-rule “scale of pay” means the revised scales of pay specified in respect of various posts in the Karnataka Civil Services (Revised Pay) Rules, 2018 and related orders.

3. Amendment of rule 9:- In the rule 9 of the said rules, in sub rule(2),-

- (i) in clause (bb), for the words and figures “not less than Rupees 48900-63600” the words and figures “not less than Rupees “90500-123300” and for the words and figures “not more than Rupees 30400-51300” the words and figures “not more than Rupees 56800-99600” shall be substituted.
- (ii) in clause (bbb), for the words and figures “less than Rupees 48900-63600” the words and figures “less than Rupees 90500-123300” shall be substituted.
- (iii) in clause(bbb-1), for the words and figures “for the pay scale of Rupees 40050-56550”, the words and figures “for the pay scale of Rupees 74400-109600” shall be substituted.

4. Amendment of Rule 10 :- In Rule 10 of the said Rules, in sub rule (8) in serial number (10), “for the figures “40050-56550” the figures “74400-109600” shall be substituted.
