NOTIFICATION

Whereas the draft of the following rules further to amend the Karnataka Civil Services (Classification, Control and Appeal) Rules, 1957, was published as required by clause (a), sub-section (2) of section 3 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) in Notification No. DPAR 6 SDE 2012, Dated: 02.03.2019, in Part IV A (P.R.No.157) of the Karnataka Special Gazette dated 02.03.2019 inviting objections and suggestions from all persons likely to be affected thereby within fifteen days from the date of its publication in the Official Gazette.

Whereas, the said Special Gazette was made available to the public on 02.03.2019.

And Whereas, no objections, and suggestions have been received in this behalf by the State Government.

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) the Government of Karnataka hereby makes the following rules, namely:-

RULES

1. Title and commencement:- (1)These rules may be called the Karnataka Civil Services (Classification, Control and Appeal) (Amendment)Rules, 2019.

(2)They shall come into force from the date of their final publication in the official Gazette.

2. Amendment of Schedule II:- In the Karnataka Civil Services (Classification, Control and Appeal) Rules, 1957, (hereinafter referred to as the said rules), in Schedule II, for the heading "Karnataka Government Secretariat", and entries relating thereto the following shall be substituted, namely:

Explanation:

(i) “Under Secretary, Department of Personnel and Administrative Reforms”, means Under Secretary to Government in the Department of Personnel and Administrative Reforms in charge of the matters relating to service conditions of Group-D officials of the Karnataka Government Secretariat,

(ii) “Under Secretary concerned”, means the Under Secretary to Government including Ex-officio Under Secretary in any Department of Secretariat including Department of Cabinet Affairs other than Department of Personnel and Administrative Reforms to whom the concerned Group-D official is subordinate at the time of taking action under these rules and in the case of Group-D officials of the Personal Establishment of Secretary, Special Secretary and or Additional Secretary, Joint Secretary and Deputy Secretary to Government, the Under Secretary of the Department incharge of the establishment matters of that Department.
