**THE KARNATAKA LAND REVENUE AND CERTAIN OTHER LAWS
(AMENDMENT) ACT, 2007**

(Received the assent of the Governor on the eighth day of May, 2007)

An Act further to amend the Karnataka Land Revenue Act, 1964 and certain other laws in the State of Karnataka.

Whereas, it is expedient further to amend the Karnataka Land Revenue Act, 1964 (Karnataka Act 12 of 1964) and certain other laws for the purposes hereinafter appearing;

Be it enacted by the Karnataka State Legislature in the fifty-eighth year of the Republic of India, as follows:-

1. Short title and commencement.- (1) This Act may be called the Karnataka Land Revenue and Certain other laws (Amendment) Act, 2007.

(2) It shall be deemed to have come into force from Fifth day of January 2007.

13. Amendment of the Karnataka Scheduled Castes and Scheduled Tribes and Other Backward Classes (Reservation of appointments, etc.) Act, 1990 (Karnataka Act 7 of 1991).- In the Karnataka Scheduled Castes, Scheduled Tribes and Other Backward Classes (Reservation of appointments, etc.) Act, 1990 (Karnataka Act 7 of 1991), in section 4-D, sub-section (3) shall be omitted.

14. Amendment of the Karnataka Regularisation of Unauthorised Constructions in Urban Areas Act, 1991 (Karnataka Act 29 of 1991).- In the Karnataka Regularisation of Unauthorised Constructions in Urban Areas Act, 1991 (Karnataka Act 29 of 1991), in section 8A, in the heading and in the section for the word "Divisional Commissioner" the word "Regional Commissioner" shall be substituted.

15. Amendment of the Karnataka Panchayat Raj Act, 1993 (Karnataka Act 14 of 1993).- In the Karnataka Panchayat Raj Act, 1993 (Karnataka Act 14 of 1993), in section 2, in sub-section (7), for the words "Divisional Commissioner" the words "Regional Commissioner" shall be substituted.

16. Amendment of the Hindu Religious Institutions and Charitable Endowments Act, 1997 (Karnataka Act 33 of 2001).- In the Hindu Religious Institutions and Charitable Endowments Act, 1997 (Karnataka Act 33 of 1997), in section 63.-

- (i) In the heading for the word "Commissioner" the words "Regional Commissioner" shall be substituted;
- (ii) In sub-section (1), for the word "Commissioner" in the two places where they occur the words "Regional Commissioner" shall be substituted;

- (iii) In sub-section (2), for the word "Commissioner" in the two places where they occur the words "Regional Commissioner" shall be substituted.

17. Amendment of the Karnataka Rent Act, 1999 (Karnataka Act 34 of 2001).- In the Karnataka Rent Act, 1999 (Karnataka Act 34 of 2001), in section 2, in sub-section (3), in clause (a), in the explanation for the words "Divisional Commissioner" the words "Regional Commissioner" shall be substituted.

The translation of sections 13 to 17 of the Karnataka Land Revenue and Certain other laws (Amendment) Act, 2007 (Karnataka Act No 17 of 2007) be published in the Official Gazette under clause (3) of Article 348 of the Constitution of India.
